SKEF CET Aftercare Onsite at Howard Street

WHEN: June 25th-July 27th (*no program on July 4th.*) Monday-Friday from CET program end (as early as 12:30) until 5:30pm

WHAT: SKEF will provide a complementary program for the CET student focusing on arts, music, large motor movement, garden and STEM. Program will consist of weekly themes that will revolve through those subject areas. SKEF will provide all materials. Parents will send lunches.

TARGET AGE: any CET enrolled student is welcome.

COST: A season pass for SKEF Aftercare is a maximum of \$362/child/season and will decrease as more than 15 students are enrolled.

SKEF Aftercare FAQs

Where will care be provided?

• The SKEF aftercare program for CET will be provided at Howard Street, between classroom and outside activities.

I have one child that is dismissed at 12:30 and another at 2:30 a few days a week, how does that work?

• The SKEF aftercare program is designed for families/carpools with multiple dismissals in mind. It is onsite at Howard Street and children can check-in when they are dismissed from CET.

How many children can be accommodated?

• Initial projections are up to 30 children however it is likely that additional teachers could be added depending on need. *The best way to guarantee your spot is to register early.*

I don't need aftercare every day, but I will need some, especially as it gets to the end of the session, is there a drop-in option?

We hope to develop a drop-in option for the summer. It would be available on a space available basis. If you are interested in the drop-in option, please <u>click here</u> (<u>https://www.surveymonkey.com/r/CDJ5D79</u>) to be added to the interest list. Signing up for the interest lists helps us best tailor a drop-in program based on the need. The best way to guarantee a spot is to register for the seasons pass to have that time available, and the more that are registered the less expensive it is for all.

Who will be providing the supervision?

• SKEF will be using the same trained specialists that are also employed during summer camps. There will be a minimum of two teachers onsite at all times.

SKEF provides other elementary and middle school summer programs. Will the CET site be open to any families?

 The SKEF program at Howard Street will be exclusively for CET enrolled students. It will only be providing care while CET is in session, June 25th – July 27th.

We are already enrolled at our school site for year-round SKEF care, including summer camp. Will this be an additional fee?

 Families that are enrolled in SKEF's "Option 3" program will continue to pay the Option 3 monthly fee and will have the CET aftercare summer pass enrollment fee waived. Contact Jodi Blackman or Megan Brown at SKEF to make sure you have any additional questions answered, to confirm eligibility and to complete any special registration steps.

Is the SKEF CET Aftercare summer pass included in the CET tuition or is it separate?

 It is separate. Both portions of care during the day are being provided by two different organizations, but coordinated for the convenience of CET families and held and in the same facility. CET registration is handled through the CET system and SKEF aftercare is handled through the SKEF registration and payment system.

Will I have a way to reach SKEF teachers directly when my pickup plans change for the day?

• SKEF will provide contact information for the SKEF Aftercare program to enrolled families for open communication.

There isn't a set price for the aftercare program. How does it work?

- SKEF will provide the aftercare for the CET season at cost. As a result, the exact cost to
 families won't be set until families are signed up and total number of children is known.
 The cost per child when 15 children are enrolled is \$362. As an example for how costs
 will be reduced: with 20 children enrolled, the season pass cost is \$272. How it works;
 - Children are registered with SKEF with a \$50 deposit to guarantee their spot with a maximum price of \$362/child for a season pass. If there are not 15 children registered by May 1st, the SKEF aftercare program will not be able to be provided and deposits will be returned.
 - \circ All enrolled families will pay less when more than 15 children are enrolled.
 - \circ 1/2 of the summer pass fee is due by May 15th, with the other 1/2 due by June 15th.

I don't see information about this on SKEF's site, where do I get answer to my questions?
